IMPORTANT NOTICE REGARDING SEMI ONLINE COUNSLIING (STRAY ROUND) FOR LEFTOVER SEATS OF ANM/GNM COURSES ADMISSION 2024-25

The admission process for the regular batch has been completed as per the timelines of INC (i.e., 31-10-2024). Admissions completed after 31-10-2024 and up to 30-11-2024 are being considered as irregular batch, as per INC Notification No. 14 dated 28-10-2024. After Semi Online Counselling held from 27-11-2024 to 29-11-2024, many institutes still have vacant position as a number of students have surrendered their seats due to admission in B.Sc Nursing or various other reasons.

In this regard, all ANM and GNM institutes are informed that the Semi Online Counselling (Stray Round) for leftover seats under the irregular batch will be conducted at the institute level under the supervision of the Principal of the respective institute. The seats allotted under Semi Online Round shall be confirmed on Institute's login on PNRC portal before starting the Stray Round. The process will follow the steps outlined below:

1. Eligibility Criteria

- Candidates must meet the eligibility as per the Prospectus for admission in GNM & ANM for the session 2024-25, published on PNRC Website i.e. www.pnrconline.in.
- The candidates who have completed online application in all respects on Counselling admission portal 2024-25 of PNRC shall be allowed to appear in this round.
- Candidates who are not holding any seat in any institute will be able to participate in the Stray Round of Semi Online Counselling. If any candidate has already joined anywhere then the candidate has to surrender his/her current seat to participate in this round. The surrendered seat shall not be reverted irrespective of allotment in this round in any circumstances.
- Candidates need to carry Original Documents for verification purposes.
- Seat upgradation will not be allowed to the candidates who have been allotted seat during any round of semi online counselling. Candidates will not be able to shift to any other institute if they are offered seat in this round.

2. Process to be carried out under Supervision of The Principal

- Candidates eligible for admission under Stray Round of Semi Online Counselling have to reach and report respective college at 9am. Last reporting time for the candidates is till 10am.
- The Principal will be provided access to a portal where they must mark the students who have reported in the institute for Stray Round of Semi Online Counselling. Based on this information, a merit list will be automatically generated by the system.
- The Principal shall call candidates on priority as per Merit List and the candidate's attendance shall be marked by taking signatures of candidates on the Allotment Sheet.
- The candidate's eligibility and inspection of original documents shall be sole responsibility of the Principal. The eligible candidates can be allotted the seat subject to availability.

- The Institutes shall adhere to the Vacancy Position published on website and the number of seats allocated in stray round shall not exceed the number of seats indicated in Vacancy Position. Violation shall attract cancellation of seats allotted under stray round.
- After the allotment of seats, institute will have to Verify/Confirm various joining process on admission portal as per usual practice during the counselling. This will be final step of admission and without execution of this step the seats shall not be confirmed and it shall be presumed that no admissions are made..

3. Submission of Original Record

- The institute shall submit original record of both rounds of Semi Online Counselling on or before 05-11-2024.
- Original record shall include;
 - O Merit List
 - Allotment Sheet
- Failing to submission of original record shall imply cancellation of seats allotted in Semi Online Counselling of the respective institute.

Sub: Extension of Last date of Admission for the all Nursing Programs for Academic year 2024-25- reg.

In continuation to earlier notification no. 11 of 2024 dated 20.09.2024, Indian Nursing Council has considered the request from the States with respect to extension of last date of admission for all nursing programs ie. ANM, GNM, B.Sc.(N), PBB.Sc.(N), M.Sc.(N), Post Basic Diploma and NPCC for the Academic Year 2024-25 till **30**th November 2024.

The total number of students admitted upto 31st Oct 2024 (regular batch) and 30th Nov 2024 (irregular batch) should add up to the sanctioned strength and shall not exceed the Annual intake.

NOTE:

It shall be ensured that the INC guidelines with respect to completion of syllabus in various nursing programmes be strictly followed.

(i) For B.Sc.(N)- The Universities/ Colleges of Nursing shall implement the B.Sc.(N) semester wise. In this context, it is clarified that the students who are admitted upto 31st Oct 2024 shall be considered as REGULAR BATCH. The students admitted from 1st Nov 2024 onwards will be considered as IRREGULAR BATCH. Examination shall be conducted separately for the above batches. Universities shall ensure that institution shall comply with semester requirements as prescribed in the syllabi before the conduct of examination:

- (a) A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course/ subject for appearing for examination.
- (b) A candidate must have 100% attendance in each of the practical areas before award of degree.

(ii) For GNM- a candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination. The diploma shall not be awarded to the student till she/ he has completed the clinical/ field requirement.

(iii) For ANM- at least 80% of all the clinical requirement should be completed before appearing for the final (second year) examination and should have acquired the requisite competencies as listed in the syllabus before the award of the certificate/ diploma by the State Nursing Council / Examination Board.

No request for further extension shall be considered.
