

# **IMPORTANT NOTICE REGARDING SEMI ONLINE COUNSELLING FOR LEFTOVER SEATS (ANM & GNM) – IRREGULAR BATCH**

Admission process for Regular Batch has been completed as per timelines of INC i.e. on or before 31-10-2024. Admission done after 31-10-2024 till 30-11-2024 shall be considered as Irregular batch as per INC Notification No. 14 dated 28-10-2024. In this regard, it is informed to all ANM & GNM Institutes that the process for counselling of leftover seats under irregular batch will be conducted at institute level under the supervision of official appointed by PNRC, as per following process.

## **1. Submission of Online Request by Institutes:**

All institutes who wish to conduct the counselling of the leftover vacant seats for their institute are required to submit an online request from their portal to Punjab Nurses Registration Council (PNRC).

## **2. Approval by PNRC:**

Upon receipt of the request, PNRC will review, approve and decide counselling schedule for the particular institute.

## **3. Semi Online Counselling at Institute level:**

Upon final date approved from PNRC, the institute will publish newspaper advertisement and will conduct the semi online counselling at their premises for leftover seats for ANM and GNM courses – irregular batch in the presence of official appointed by PNRC. Specimen of Advertisement is enclosed.

## **4. Student Reporting and Merit List Generation:**

During the Semi Online counselling, official appointed by PNRC will be provided access to a portal where they must mark the students who have reported in the institute for institute level counselling. Based on this information, a merit list will be automatically generated by the system. Seats will be offered by official appointed by PNRC to students as per the merit list. The final allocation sheet along with advertisement copy need to be shared on portal for finalization.

## **5. Confirmation by Institute:**

After the allotment of seats by official appointed by PNRC, institute will have to Verify/Confirm various joining process on admission portal as per usual practice during the counselling. This will be final step of admission and without execution of this step the seats shall not be confirmed and it shall be presumed that no admissions are made.

## **Note:**

- All institutes are advised to strictly adhere to the guidelines of PNRC/INC. Non-compliance may result in disqualification from conducting the counselling process.
- The candidates who have completed application in all respects on Counselling admission portal 2024-25 of PNRC till 26-11-2024 (5 PM only) shall be allowed to appear in this round. After preparation of merit list no candidate shall be allowed to participate.
- Candidates who are not holding any seat in any institute will be able to participate in the semi online counselling. If any candidate has already joined anywhere then the candidate has to surrender his/her current seat by 25-11-2024 (6 PM) to participate in this round. The surrendered seat shall not be reverted irrespective of allotment in this round in any circumstances.
- Candidates need to carry Original Documents for verification purpose.
- Seat upgradation will not be allowed to the candidates who have been allotted seat during this round of semi online counselling. Candidates will not be able to shift to any other institute if they are offered seat in this round.

**NOTIFICATION No. 14 of 2024**

**Sub: Extension of Last date of Admission for the all Nursing Programs for Academic year  
2024-25- reg.**

In continuation to earlier notification no. 11 of 2024 dated 20.09.2024, Indian Nursing Council has considered the request from the States with respect to extension of last date of admission for all nursing programs ie. ANM, GNM, B.Sc.(N), PBB.Sc.(N), M.Sc.(N), Post Basic Diploma and NPCC for the Academic Year 2024-25 till **30<sup>th</sup> November 2024**.

The total number of students admitted upto 31<sup>st</sup> Oct 2024 (regular batch) and 30<sup>th</sup> Nov 2024 (irregular batch) should add up to the sanctioned strength and shall not exceed the Annual intake.

**NOTE:**

It shall be ensured that the INC guidelines with respect to completion of syllabus in various nursing programmes be strictly followed.

(i) **For B.Sc.(N)-** The Universities/ Colleges of Nursing shall implement the B.Sc.(N) semester wise. In this context, it is clarified that the students who are admitted upto 31<sup>st</sup> Oct 2024 shall be considered as REGULAR BATCH. The students admitted from 1<sup>st</sup> Nov 2024 onwards will be considered as IRREGULAR BATCH. Examination shall be conducted separately for the above batches. Universities shall ensure that institution shall comply with semester requirements as prescribed in the syllabi before the conduct of examination:

- (a) A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each course/ subject for appearing for examination.
- (b) A candidate must have 100% attendance in each of the practical areas before award of degree.

(ii) **For GNM-** a candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination. The diploma shall not be awarded to the student till she/ he has completed the clinical/ field requirement.

(iii) **For ANM-** at least 80% of all the clinical requirement should be completed before appearing for the final (second year) examination and should have acquired the requisite competencies as listed in the syllabus before the award of the certificate/ diploma by the State Nursing Council / Examination Board.

**No request for further extension shall be considered.**
